FROZEN WHOLE EGG

PRODUCT DESCRIPTION:

• Pasteurized Frozen Whole Egg is prepared from chicken eggs. Eggs are washed and sanitized prior to being broken. The product is pasteurized to maintain product quality and integrity.

INGREDIENTS:

• Frozen Whole Egg.

PROPERTIES:

Frozen Whole Egg has an odour and taste typical of egg.

APPLICATION:

• Frozen Whole Egg can be used in applications such as cookie mixes, cake mixes, noodles, mayonnaise, custards, pastas and other food products requiring a substitute for shell eggs.

CERTIFICATIONS:

• Frozen Whole Egg is Kosher Dairy and Halal certified.

CONTINUING PRODUCT GUARANTEE:

• Vanderpol's Eggs Ltd. (Federal Registration # 66) certifies that all of their egg products comply with the Canadian Food Inspection Agency (CFIA) requirements.

The CFIA regulates egg products leaving federally inspected establishments or being imported into Canada to verify they are safe, wholesome, labelled to avoid misleading consumers and eligible to be traded interprovincially or internationally.

The key acts and regulations CFIA enforces are the Egg Regulations under the Canadian Agricultural Products Act and the Food and Drug Regulations under the Food and Drugs Act.

Vanderpol's Eggs Ltd. guarantees that all egg products are manufactured, packaged, stored, and shipped in accordance with GMP guidelines, and under strict sanitary guidelines to minimize the possibility of contamination.

LOT CODING:

• The product lot is generated based on the date the product is produced and expressed in the format: DDMMY (e.g. 30096 for 30 September 2016).

PACKAGING:

• Frozen Whole Egg is available in cases of 6 x 2kg cartons.

STORAGE CONDITIONS:

• Frozen product should be stored at -18°C (0°F) +/- 5°C. Products for thawing should be stored under refrigeration at 1-4°C (33-40°F), with a minimum of 3 days required for thawing. Use thawed product within 7 days of opening.

Extended storage outside the conditions specified above may impact product quality and functionality.

SHELF LIFE:

• Shelf life is one year when kept frozen in its original packaging, unopened.

LEGISLATION:

All egg products processed at Vanderpol's Eggs Limited:

- meet the requirements of the Food and Drugs Act and the Food and Drug Regulations;
- are prepared in accordance with these Regulations;
- are prepared in a registered processed egg station;
- are as free from egg shell as the exercise of reasonable care and diligence in its preparation makes possible;
- are smooth in texture and well blended (excluding hard cooked eggs);
- test negative for salmonellae and other pathogenic organisms of human health significance as determined by a

method approved by the Minister;

- are not adulterated; and
- are not contaminated.
